
TOTAL POPULATION















Households by Composition and Relationship to Householder



Summary of Demographics

According to the American Community Survey (ACS) 2013-17 5-year estimates, there were a total of 86,501 people residing in Auglaize and Mercer Counties combined. There were slightly more in Auglaize County (45,778) than Mercer County (40,723). Between the years 2000 and 2010, the Census Bureau indicates a slight decrease in the population totals for the two counties, from 87,535 to 86,763, a deficit of 772 individuals. Majority of this change occurred in Auglaize County, as 662 of those 772 individuals originally resided in that county.

The age group of 5-17 comprises the largest population in Auglaize & Mercer Counties with a total of 15,896. This age group makes up 18.02% of the population in Auglaize County and 18.78% of the population in Mercer County. The southern half portion of Mercer County consists of over 26% of the population age 0-17, with small portions in southwest Auglaize County as well.

An estimated 16.81% of the population in the report area is age 65 or older according to the U.S. Census Bureau American Community Survey 2013-17 5-year estimates. An estimated total of 14,537 older adults resided in the area during this time period. This number is higher than both state of Ohio (15.89%) and United States (14.87%) estimates. In the report area, 13.35% of male population are at age 65+, and 18.71% of female population are at age 65+.

It was reported by the University of Wisconsin Net Migration Pattern for U.S. Counties that the net migration rate of the total population of the two counties between 2000-2010 decreased a total of 4.19%. Overwhelmingly, the age group with this highest rate for both Auglaize (-33.72) and Mercer (-34.72) Counties was age 20-29 years when compared to second lowest (-6.23) between the two counties.

Auglaize and Mercer Counties experience a population of 267 linguistically isolated individuals. Of the 267 individuals, 93 reside in Auglaize County and 174 reside in Mercer County, according to the American Community Survey (ACS) 2013-17.

In the report area, 23.44% of the housing units are renter-occupied. This number is lower than the Ohio and United States percentages of 33.94% and 36.18%, respectively. Southeast Mercer County has a large area experiencing between 22.1-30.0% as being renter occupied, and the middle portion of their county experiencing 30.0-38.0%. Auglaize County is also experiencing a large number of renter-occupied housing units, especially along the Mercer County border (30.1-38.0%) and on the county's northern border (22.1-30.0%).

In the report area, 69.91% of the total household population is family households. This is higher than both Ohio (63.81%) and United States (65.89%) numbers. Majority of the family households in the report area are married, totaling 22.07%. Again, this percentage is more than both Ohio (18.36%) and United States (20.59%). Single-female family households comprise 5.61% of the household types in the report area with Auglaize County containing more than Mercer County with a comparison of 6.54% to 4.57%. Single-male family households are lower making up 2.66% of the family households, this time with Mercer County being more than Auglaize County with a comparison of 3.23% to 2.16%.

Interestingly, Auglaize and Mercer Counties had near opposite numbers for those residing in areas identified as urban and rural. Auglaize County consists of 60.86% urban population versus 38.64% in Mercer County. For the rural population, Mercer County exceeds Auglaize County with 61.36% compared to 39.14%.

Social & Economic Factors

Economic and social insecurity often are associated with poor health. Poverty, unemployment, and lack of educational achievement affect access to care and a community's ability to engage in healthy behaviors. Without a network of support and a safe community, families cannot thrive. Ensuring access to social and economic resources provides a foundation for a healthy community.

CHILDREN ELIGIBLE FOR FREE/REDUCED PRICE LUNCH

Within the report area 4,247 public school students or 26.98% are eligible for Free/Reduced Price lunch out of 15,742 total students enrolled. This indicator is relevant because it assesses vulnerable populations which are more likely to have multiple health access, health status, and social support needs. Additionally, when combined with poverty data, providers can use this measure to identify gaps in eligibility and enrollment.





% Population Age 25+ with No High School Diploma








INCOME – MEDIAN HOUSEHOLD INCOME








Population Receiving SNAP Benefits, Percent by County, SAIPE 2015



Population Below the Poverty Level, Percent by Tract, ACS 2013-17





Summary of Social & Economic Factors

According to the National Center for Education Statistics (NCES), 4,247 (26.98%) of the 15,742 total enrolled public school students are eligible for Free/Reduced Price lunch. This number is just slightly below Ohio which consists of 27.32%. This number has risen each year between the years 2010 - 2015, with the highest reported as 30.49% for both counties combined. This number has since decreased each year between 2015-2017, with a reported 26.98% in 2017.

According to data acquired from the US Department of Health and Human Services (HHS) 2018 Head Start Locator, Auglaize and Mercer Counties both have two of the 723 Head Start Programs in the state of Ohio. The high school graduation rate, reported by the US Department of Education, is 95.6% for the report area. This exceeds the high school graduation rate for both Ohio (90.6%) and United States (86.8%). The high school graduation rate for the report area is adequate as education is linked to positive health outcomes.

Of the 34,484 total occupied households in the report area, 1,528 or 4.43% are reported as having no motor vehicle according to the American Community Survey (ACS) 2013-17.

The median household incomes for Auglaize and Mercer Counties are \$59,516 and \$57,052 respectively. There is a large lack of data for median household incomes when broken down by race/ethnicity of householder. The only races/ethnicities with full reports are Non-Hispanic White and Asian.

Of the 86, 844 individuals in the report area, 5,754 or 6.6% are receiving SNAP benefits. More individuals in Auglaize County receive SNAP benefits as opposed to Mercer County with a difference between 3,463 (7.6%) in Auglaize County and 2,291 (5.6%) in Mercer County.

Within the report area 8.28% or 7,068 individuals are living in households with income below the Federal Poverty Level. 9.04% of the individuals residing in Auglaize County fall in this category, while 7.43% of Mercer County residents have an income below the Federal Poverty Level. Of the population living below the Federal Poverty Level, 45% in Auglaize County are identified as Black or African American. Mercer County's highest population in poverty by race is 22.41% who identify as Asian.

The Unemployment rate, according to the US Department of Labor, indicates 1,444 or 2.9% of the 49, 545 in the labor force are unemployed in the two counties combined.

Physical Environment

A community's health also is affected by the physical environment. A safe, clean environment that provides access to healthy food and recreational opportunities is important to maintaining and improving community health.

BUILT ENVIRONMENT - BROADBAND ACCESS

This indicator reports the percentage of population with access to high-speed internet. Data are based on the reported service area of providers offering download speeds of 25 MBPS or more and upload speeds of 3 MBPS or more. This data represent both wireline and fixed/terrestrial wireless internet providers. Cellular internet providers are not included. Broadband Access, Pct. Population in a High-speed Internet Service Area by Tract, FCC June 2018









Summary of Physical Environment

The percentage of population with access to high-speed internet is reported as 97.17% for the report area, exceeding Ohio (94.96%) and the United States (94.29%).

The U.S. Census Bureau reports a total of 6 grocery store establishments in Auglaize County and a total of 9 grocery store establishments in Mercer County. The number of grocery stores and supermarkets decreased in the report area between 2010-2016, while the number in the United States slightly increased.

There are individuals in the report are with low or no healthy food access and the racial disparity index score is high. A score over 15 is considered "high disparity" and both the counties, the state of Ohio and the United States are all over the score of 15. Auglaize is the highest with a score of 27.23 and second highest is Mercer County with a score of 18.35. Ohio and the United States are slightly above the score of 15 with 16.49 and 16.59 respectively.

A total of 19.95% of the households in the report area have housing costs that exceed 30% of total household income according to the US Census Bureau, American Community Survey, 2013-17. In the report area, 34.09% of the rental households are cost burdened. Owner-occupied households with and without mortgages are lower with 19.77% and 10.18% respectively.

In the report area, occupied housing units by both owners and renters have reported a percentage of one or more substandard conditions. In Auglaize County, 20.32% have reported substandard conditions. Very similarly, Mercer County reported 20.14% of their occupied housing units as having one or more substandard condition. In Auglaize County there were 100 housing units lacking complete plumbing facilities and only 3 in Mercer County. The condition the units lacked the most was complete kitchen facilities with 2.94%, while lacking complete plumbing facilities totaled 0.33%.

Clinical Care

A lack of access to care presents barriers to good health. The supply and accessibility of facilities and physicians, the rate of uninsurance, financial hardship, transportation barriers, cultural competency, and coverage limitations affect access. Rates of morbidity, mortality, and emergency hospitalizations can be reduced if community residents access services such as health screenings, routine tests, and vaccinations. Prevention indicators can call attention to a lack of access or knowledge regarding one or more health issues and can inform program interventions.





Summary of Health Behaviors

The age-adjusted percentage of estimated adults drinking (alcohol) excessively in the report area exceeds both the Ohio and United Stated percentages. According to the Center for Disease Control and Prevention, 24.7% are reported in two county area as drinking excessively, while only 18.4% in the state of Ohio and 16.9% in the United States.

The tobacco expenditures also exceed both the numbers for Ohio and the United States. "Nielsen Site Reports" estimated in 2014 that cigarette expenditures comprised 2.15% of Auglaize and Mercer County's total household expenditures, while Ohio was 1.92% and the United States was only 1.56%.

Within the report area, 18,351 or 27.6% of adults aged 20 and older self-report no leisure time for activity, exceeding both Ohio and the United States who are identified as 25.4% and 22.8% respectively.

For Health Behaviors, Auglaize County and Mercer County both exceed Ohio and the United States in all areas besides those who self-report smoking cigarettes.

Health Outcomes



Summary of Health Outcomes

Auglaize and Mercer Counties reported the rate of death due to motor vehicle crashes between 2012-2016 as 12, which exceeds Ohio (9.84) and the United States (11.5). Total pedestrian deaths from 2011-2015 calculated as 4 in Auglaize County and 1 in Mercer County.

36.8% of adults aged 20 and older self-report that they have a Body Mass Index (BMI) greater than 30.0 (obese) in the report area. This number exceeds both Ohio (32.1%) and the United States (28.8%). Slightly more females reported a high BMI (> 30.0) than males in the report are by a difference between 37.9% and 35.6%. In the year 2016, the percent of adults reported as obese with a BMI>30.0 was the highest it had ever been since 2004. Excess weight may indicate an unhealthy lifestyle and puts individuals at risk for further health issues.

Within the report area , 19.2% of adults age 18 and older self-reported poor general health. This health status is more than Ohio (15.3%) and the United States (15.7%). There were 1,210 more individuals in Mercer County that self-reported poor general health than Auglaize County.
