# **HEAP Winter Crisis Program**

Begins November 1, 2023 - March 31, 2024



helps income eligible Ohioans that are threatened with disconnection, have been disconnected, need to establish new service, need to pay to transfer service, have PIPP default, need to pay first PIPP, or have 25% (or less) supply of bulk fuel in their tank maintain their utility service.

Ohio households serviced by a Public Utilities Commission of Ohio-regulated utility must sign up for the Percentage of Income Payment Plan Plus (PIPP) or another payment plan if there is still an outstanding balance on the bill after receiving assistance

## Who Is Eligible?

- Household income at or below 175% of the federal poverty guidelines
- Facing disconnection
- Have been disconnected
- Have less than a 25% supply of bulk fuel in their tank

## **Required Documents**

- Income for primary applicant and all household members 18 years of age or older
- Social Security numbers for primary applicant and all household members
- Most recent utility bills
- Proof of citizenship for all household members

# Baked Cinnamon Sugar Apple Chips

#### Ingredients:

- 3 medium apples
- 1/4 c. sugar
- 1/2 T. ground cinnamon

#### **Directions:**

- Preheat oven to 225 degrees
- Line two baking sheets with silicone baking mats or parchment paper. Set aside
- Have an \*adult\* use a knife to thinly slice the apples
- Evenly, spread the apple slices onto the prepared baking sheets
- Sprinkle cinnamon sugar mixture over top of each apple slice
- Bake for 1 hour, flip the apples over, sprinkle with more cinnamon sugar, and bake for another hour

As November is here, I wanted to let new parents know about Policy Council. Did you know without parent involvement, Head Start's around the United States would not be able to function? If you're wondering what a Head Start's Policy Council is, let me explain.

Policy Council is necessary for approving decisions about Head Start. Those decisions include activities and involvement of parents, financial monthly statements, remodels or new builds, and also the hiring of employees. That's all fine and dandy, but why do parents have to join? It is necessary for parents to be on the Head Start Policy Council because it ensures unbiased decisions and makes for less ability of a conflict of interest, especially since you sign a form when your term begins. It is required that the Council be made up of 51% parents.

A personal reason I chose to join is to have a better understanding of how Head Start runs. Now that I am involved, the opportunities to help advocate for our teachers and our school on different platforms has become an apparent need. While I still remain a part of the Council to advocate for your children and mine, I have learned that it has always been so much more. Being on Policy Council gives you a sense of standing up for the community, the parents, the children, the staff and the program itself. If you weren't thinking about joining Policy Council as your Classroom Representative or Co-Rep, please read this and give it a thought. Your questions are valid, your concerns are heard, and you'll be helping your child become kindergarten ready.
